

30-YEAR LIMITED SUBSTRATE WARRANTY

RISE® Siding, RISE® Trim and RISE® Sheets

This warranty covers the following RISE® Composite Technologies (RCT) siding, trim and sheet products for a period of thirty (30) years from the date of the original consumer purchase from an authorized RCT distributor.

RCT (Warrantor) warrants the RISE Building Products family of products – RISE Siding, RISE Trim and RISE Sheets to remain free from fungal decay and delamination of the substrate when used in normal residential applications, and installed and maintained according to the manufacturer's installation instructions. It is required for the substrate to be painted.

RCT (Warrantor) does not warrant damage resulting from improper fastener installation, hail, improper storage, shipping and handling of product, alteration of product after shipping, neglect, repair or alteration, improper installation, damage from the settling of the house, mold, mildew and acts of God, such as hurricane, tornado, flood, earthquake, severe weather, or other natural phenomena beyond the control of RCT. RCT does not warrant any cause other than manufacturer's defective material or workmanship.

Purchaser's sole remedy for any claim whatsoever arising out of the purchase, use, storage or possession of RCT products (whether such claim arises is contract, warranty, tort, strict liability or otherwise), including without limitation any claim that RCT products failed to perform as defective material as listed on the prorated warranty schedule. Replacement material will be provided that is as close as possible in color, design, and quality to the original installed product, but RCT does not guarantee an exact match, as colors and designs may change. Warrantor may elect to refund the percentage of the original purchase price listed on the Product Warranty Schedule in lieu of replacing the product.

To obtain replacement, the original owner must send this warranty certificate, copy of original invoice, and photos of the issue to the address at the bottom of this document. Such invoice must be from an authorized RCT product dealer or professional installer, and must show (1) the date of the purchase, and (2) that sufficient RCT product has been purchased to cover the number of lineal feet claimed to be damaged.
